Policies and Pricing

IIID members agree:

- to abide by the IIID statutes and such other policies as may be agreed upon by a majority decision taken by the General Assembly;
- to pay the membership fees for the current year;

Payment is due within 30 days of the issuing of the membership fee invoice.

If members do not pay their subscription after two reminders the membership will end.

Written notice is required for termination of Membership. If membership ends mid-way through a subscription year, no refunds of part-year subscriptions will be payable.

IIID has taken a leaf out of ico-D's book (International Council of Design) and structured its membership fees in world zones based on per capita Gross National Income (GNI) index as published by the World Bank.

Zone classifications and annual adjustments reflect data obtained from the World Bank as of 1 July of each year.

While the Zones are updated annually, the fees will be adjusted by the Secretariat every two years (non-GA years).

Zone A: GNI is USD \$10000, 100% fee

Zone B: GNI is USD \$2500 – 9999, 60% of Zone A fee

Zone C: GNI is USD \$2499, 40% of Zone A fee
